This photograph identifies the person signing this release. It will be kept with the completed release and is not authorized for publication by this form.

"Photographer" means the person identified above, operating under the listed business names. This release applies only to the session identified above.

Permission to Photograph and Record

I confirm that I am at least 18 years old. I voluntarily authorize the photographer and persons working under the photographer's direction to photograph me and record video and session-related audio, including my likeness and voice.

I may decline any pose, clothing change, or recording, and may ask to pause or stop the session. Changing clothes and private breaks will not be recorded.

Model Approval Required Before Publication

Signing this release permits creation of session content, including voluntarily posed implied-nude, topless, and nude content. It does not authorize publication of any photograph or recording. Before posting, displaying, publishing, submitting, distributing publicly, or licensing any session content, the photographer must obtain my affirmative approval of each final image or video and its intended use by email, text message, or signed approval record.

Approval must identify the final filename(s) or video version and where and how the content may be used, such as a website, social account, advertisement, or named publication. Silence, a gallery view, a favorite selection, payment, or participation in the session is not approval.

Third-party licensing: Brands, advertising partners, publishers, media outlets, and other licensees may receive or use content only after I approve the specific final content, recipient, and editorial, promotional, or commercial use by email, text message, or signed approval record. The photographer must communicate these limits to the licensee. Approval for one purpose does not authorize another.

Approval Scope and Editing

The photographer may create finished videos, reels, and behind-the-scenes content from session recordings, including combining footage with photographs, text, graphics, and appropriately licensed music.

I may approve or decline any image or video without being required to explain. Unapproved content remains private. Video approval covers the final edit, audio, and captions. Material edits, crops that change the degree of exposure, or new uses require fresh approval by email, text message, or signed approval record; routine resizing or compression does not. These approval requirements control over any conflicting provision of this release.

Normal cropping, retouching, color adjustments, and video editing are permitted. Content must not be used unlawfully, pornographically, or in a defamatory manner. Editing must not fabricate nudity or sexual activity, materially misrepresent my statements, or falsely attribute a personal testimonial or product experience to me. My appearance in authorized editorial, promotional, or commercial content does not permit fabricated statements of personal endorsement.

Ownership and Payment

The photographer retains copyright in the work they create, subject to these approval limits. Copyright ownership does not authorize publication of unapproved content.

Any agreed payment, photographs, or services exchanged for my participation are governed by our separate written agreement. Unless that agreement states otherwise, no additional payment or royalties are owed for uses authorized by this release.

Duration and Privacy

Only content approved by email, text message, or signed approval record may be used, and only within the approved scope. Unless the approval states otherwise, it has no fixed expiration. I may withdraw approval before first publication by written notice; rights to withdraw consent that cannot legally be waived remain unaffected.

Removal Requests. After publication, I may submit a removal request by email or other written notice to the photographer's notice address listed on this release. The photographer will acknowledge the request in writing within 30 days and consider it in good faith. This process does not promise removal and does not require the photographer to recall printed materials, undo completed distribution, or control copies or uses by third parties acting outside the approved scope or beyond the photographer's control. Any rights or remedies that cannot legally be waived remain unaffected.

Unapproved content may be accessed only by service providers needed for confidential editing, secure storage, or private delivery to me, with no independent publication rights. Approved content may be handled by printers, publishers, and licensees only for the approved uses.

My date of birth, contact information, and completed release will not be published. They may be shared as reasonably necessary to administer this agreement, document permission, or meet legal obligations. My name will not be publicly used or my account tagged without separate written permission.

Age and ID Verification

Before the session, I must present an original government-issued photo ID showing my legal name, date of birth, and photograph. The photographer will compare the ID with me, verify that I am at least 18, record the verification date, and retain a legible copy with the private release records. Unrelated details, such as the ID number and address, may be redacted from the retained copy unless applicable law requires otherwise. The copy will be kept in encrypted, access-restricted digital storage or a locked physical file, separate from public galleries and published work. It will be used only for age and identity verification, documenting consent, or legal requirements, and securely destroyed when no longer needed for those purposes or required by law.

Governing Law and Venue

Connecticut law governs this release, without applying its conflict-of-law rules, except where applicable law requires otherwise. To the extent permitted by law, disputes arising from this release must be brought in a state court in Hartford County, Connecticut, or the United States District Court for the District of Connecticut, sitting in Hartford, if federal jurisdiction exists. Both parties consent to those courts. This clause does not override mandatory laws or rights that cannot legally be waived. For sessions conducted outside Connecticut, this release is also intended to satisfy any applicable consent requirements of the state where the session occurs.

Severability

If a provision of this release is found invalid or unenforceable, it will be severed to the extent necessary, and the remaining provisions will continue in effect to the extent permitted by law.

Model Representations and Limited Indemnification

I confirm that the legal name and date of birth I provided are accurate, that I am the person being photographed or recorded, and that I am not impersonating or signing for another person. I have legal capacity and authority to sign this release and grant these permissions, and doing so does not violate an agreement binding on me.

To the extent permitted by law, I agree to indemnify the photographer for reasonable, documented losses and legal fees resulting directly from a third-party claim caused by my knowingly false statements about my identity, age, or authority to sign. This obligation does not cover losses caused by the photographer's unauthorized use, negligence, intentional misconduct, or breach of this release.

Electronic Records and Signatures

If the parties choose to complete this release electronically, they consent to electronic records and signatures for this agreement. An electronic signature intentionally adopted to sign this release is intended to have the same effect as a handwritten signature, to the extent permitted by law. Each party will receive a completed copy that can be saved or printed. Either party may request paper signing before signing electronically.

Release and Agreement

To the extent permitted by law, I release the photographer and persons acting with the photographer's authorization from claims arising solely from uses that comply with this release. This does not excuse unauthorized use, negligence, intentional misconduct, or breach of this agreement.

I have read this release and agree voluntarily. The photographer agrees to obtain and retain my approvals by email, text message, or signed approval record before publication or licensing. Changes must be agreed in writing. Both parties will receive a completed copy of this release and the approval records.
